- Re-establish us as a community hub and advocate. People miss our presence and involvement.
- The low-income community doesn't think they can shop at the Co-op so many of them don't. We could do more helping people understand what is affordable at the Co-op and the value it can have for their nutrition.
- The Co-op is looking at how to address price perception and how we address package size for different types of customers
- O Nutrition education is an area we could focus on
- o Connection of regenerative/organic agriculture to functional medicine/health/nutrition
- The Strategic Planning Committee is now a broader group of Board members
- The hope is we can have a rough draft of the Strategic Plan for member review at the March Annual Meeting
