### **Member Civic Engagement Request**

- Six Co-op members attended the MAC meeting to share their concerns that the Co-op is contributing to current human rights atrocities by selling Israeli produced products.
- They spoke to our Co-op mission values statements and noted that adherence to human rights principles should be the primary concern when selecting products.
- They highlighted examples of when the Co-op has previously made decisions to remove items from their shelves in line with our values (ex. Eden Foods, grapes, chocolate, fish)
- A MAC member asks if we would be hurting the food producers that don't support what the government is doing and penalizing the wrong people.
- Boycotts are typically approached with a lens on a specific company, this would be focused on a whole country.
- The hope is by the Co-op removing the products it is an educational opportunity for the shopping public to highlight current events.
- The members would be open to speaking with Rabbi Josh or members of the Arab community.
- MAC will debrief and share an update to the Board.
